#### PURPOSE OF THE REPORT

#### **KEY POINTS**

The Quality Report for 2022/23 was presented and approved at the Private Board of Directors meeting held on 27 June 2023 to ensure compliance with publication timelines. A copy of the report can be found here.

#### Part 3

Quality performance information, reporting on the previous year's performance against defined indicators. This content is common to all providers' Quality Reports enabling comparison across organisations.

Following review at TEG on the 17 May 2023, the Quality Report was reviewed by the Overview and Scrutiny Committee, South Yorkshire Integrated Care Board (SY ICB) and Sheffield Healthwatch and their comments are included in the report. The report was also presented at the Public Board of Directors meeting on 25 July 2023 for information.
