PURPOSE OF THE REPORT

Council of Governors' Meeting Format: Governor Feedback Report

Following the Council of Governors Meeting held at 12:00 noon on Tuesday 20 June 2023, the 15 Governors who attended the meeting were invited to provide feedback on the new format. Feedback was received from 11 Governors giving a 73% return rate. Full details of the 11 responses can be found in appendix one. The next survey will capture views from all Governor colleagues.

Summary

On the whole Governors who responded were content with the cabaret style room layout and provided positive feedback about the venue and the overall organisation of the meeting.

Governors were content with the time of the meeting with a range of views on the most suitable day of the week.

Some of the Governors struggled to hear the discussion and commented that this was an issue.

Almost all Governors felt able to question the Non-Executive Directors during the meeting and felt that the informal NED / Governor discussion which followed the meeting was useful.



"Tuesday is an ideal day for me."


"My preference would be an afternoon meeting maybe starting just after lunch"


"Anytime to start from 10am through to 2pm. not Friday"
